

The Incident & Dockets

- Case info found at <https://ujportal.pacourts.us/CaseSearch> via a search for Incident # 1407020699.
- There are two dockets found under Incident # 1407020699: one for Defendant William Goligher, b. 1/14/1951, of Philadelphia, PA, and one for Defendant Susan Elzey, b. 9/18/69, of Haddonsfield, NJ.
- The Offense Date for this Incident was Friday, 7/18/2014.
- The Charge was a violation of Lancaster County Parks Ordinance 98-19 §§ B (i.e. 19 Personal Conduct, B “No person shall engage in any form of sexual activity.”).
- The Arresting Officer was Chief Benjamin Arnold of Lancaster County Department of Parks & Recreation.
- Both Defendants filed Guilty Pleaa on 7/31/2014.
- Note: According to Chief Arnold, Defendants were likely served citations, not actually arrested. He stated that simple traffic tickets are also written using legal terms such as "Arrest" and "Arresting Officer".

Lancaster County Parks Ordinance 98-19 §§ B

- According to Chief Arnold at Lancaster County Department of Parks & Recreation, the Park Ordinances have gone through a few changes in recent years.
- Since 2022, Ordinance 98 became Ordinance 152 became Ordinance 153 became Ordinance 158.
- According to Chief Arnold, the Department of Parks & Recreation is working to clear up any confusion the changes in the Parks & Recreation code may be causing the public.
